This release may be used against you in a court of law if you sue any released party or person. (Please read carefully, fill in all blanks, and initial each paragraph before signing.)

I, _____, hereby affirm that I am informed of the inherent hazards of horseback riding, driving, and other horse-related activities.

I understand and agree that neither Walkabout Farm, Margie Rhodes, David Farrar, nor any of their respective employees, officers, agents, or assigns (hereinafter referred to as "Released Parties") may be held liable or responsible in any way for any injury, death, or other damages to me or my family or my property, heirs, or assigns that may occur as a result of my participation in this horse-related activity unless as a result of the complete and total negligence of any party, including the Released Parties.

_____ In consideration of being allowed to participate in this activity, I hereby personally assume all risks in connection with said activity, for any harm, injury, or damage that may befall me or my property while so engaged, including all risks connected therewith, whether foreseen or unforeseen.

_____ I further save and hold harmless said activity and Released Parties from any claim or lawsuit by me, my family, estate, heirs, or assigns, arising out of my participation in this activity, including both claims arising during the activity and/or afterwards.

_____ I also understand that horse-related activities may be physically strenuous and that I may be exerting myself during this activity. I further understand that horses may behave in unpredictable and potentially dangerous ways. I expressly assume the risk of injuries resultant from my participation in these activities and I will not hold the above listed individuals or companies responsible for the same.

_____ I further state that I am of lawful age and legally competent to sign this liability release, or, that I have acquired the written consent of my parent or guardian.

_____ I understand that the terms of this release are contractual and not a mere recital, and that I have signed this document of my own free act.
